IMPORTANT CONSIDERATIONS

Form - Tax Reform - Brazil

With the aim of facilitating your process and ensuring compliance with this regulation, we have enabled a new **Billing Form** within the NDC Portal.

This form will appear in the payment section of the ticket **issuance**, **post-issuance ancillary purchase**, and **reissue** flows whenever Brazilian IATAs are being used.

Additional considerations for using the form:

- **Optional nature:** Completing this form is not mandatory. It is entirely at the discretion and judgment of the agency, according to its billing needs.
- **When selecting the “Invoice” option, most fields are mandatory; fields that are not mandatory are identified as “Optional.”**
- **Requested data:** If the agency chooses to complete it, the system will request tax information (for either a company or an individual), along with address details.
- **CNPJ and CPF must contain numbers only, with no special characters (-, /).**
- **Autofill:** To streamline the sales process, when a credit card is used during the purchase or issuance, the form will be automatically completed with the information associated with that payment method.

1- On the payment page, it is necessary to choose the payment method and, to enable the entry of the data (form), click the **“Request Invoice”** button.
